As required under Section 10 of Public Law 774 (Displaced Persons Act) and by Presidential Executive Order 10003, the following report is submitted in the case of

 Dimitrij Age 34

1. The thorough investigation which has been conducted into the character, history and eligibility of the Applicant, as supported by the statements, certifications and other documents contained in the Commission's files, has established to the satisfaction of the Commission as follows:

Character

that the Applicant is of good character and behavior;

that the Applicant is not and has not been, a member of, or participated in, any movement which is or has been hostile to the United States or the form of government of the United States;

History

That the Applicant
was born on March 25th 1916 at Rostow, Russia (Gr. Orth.)

The applicant has had three years of school in Russia. From 1929 to 1939 he was exiled at Swerolowsk, Russia. From 1939 to July 1942 he was a farm worker at Sowchos, Russia. From September 1942 to February 1943 he was a forced laborer at Brest Litowsk, Poland. From February 1943 to August 1945 he was a road worker and forest worker at Hofgastein, Austria. Since then he has lived and worked at D.P. camp Parsch, Salzburg Austria.

Eligibility

that the Applicant is a displaced person/refugee as defined in Annex 1 of the Constitution of the IRO, and is the concern of that organization;

that the Applicant entered into and was present in one of the Areas, within the appropriate dates, as prescribed in the Act.

2. The Commission further states:

that assurances have been given to the Commission on behalf of the Applicant by

that the assurances are in accordance with the requirements of the Act and regulations have been approved by the Commission, and bear the Commission (Washington) Number

That the Applicant will be employed as A-5570
And will reside at FARM LABORER

3. By virtue of the foregoing, the Commission finds:

that the Applicant is a displaced person eligible for admission into the United States under Section ^{2c} of the Act, and that such admission would be in accordance with the regulations of the Commission;

that the Applicant is entitled to

- ~~1st~~ Preference (Sec. 6a) - Agricultural Worker
- ~~2nd~~ Priority (Sec. 7) - Resident of a D.P. camp on Jan. 1st 1948

4. Therefore, in accordance with Section 700.8 (c) of the regulations, this report is submitted to the Officer of the US Foreign Service at ~~Salzburg~~ ¹⁹⁴⁸ Austria, for consideration in connection with the subject's application for an immigration visa.
